Sprague earned his bachelor's degree in communication studies in 2003 and master's in communication studies in 2005 from Colorado State University. For both degrees he had an emphasis in rhetorical studies. Sprague also played football for CSU for five years.

Sprague earned his law degree from University of Nebraska Lincoln in 2008.

Following his graduation from UNL, Sprague clerked for the U.S. Court of Appeals for the 8th circuit with Chief Judge William Riley. He served as a judicial law clerk for one year before moving his family from Omaha to Denver to take a job with Wheeler, Trigg, O'Donnell. He said the Denver firm handles primarily trial work. He spent two and a half years working with the Denver firm.
