

## Issued junk warning of concern to local citizen

Holyoke City Council members were presented with photographs of a residential yard in Holyoke by Michelle Gregg during their Tuesday, Feb. 7 regular meeting.

Gregg received a junk notice in the mail and wanted to speak with the council as she felt items in and around her yard weren't considered junk.

Gregg took some photos of her yard, which she acknowledged was "a little out of order." Gregg is concerned because she feels her "junk" items are mainly toys.

She said she has a rototiller and some tables and chairs covered with a tarp. She set kids' big wheels toys on top to help hold the tarp down since they aren't ridden during the winter.

She also said she has some construction lumber and a stack of firewood which are listed as permissible items.

"Let me know what I need to do different if it's not OK," Gregg told council members.

Council members questioned city supt. Mark Brown, who oversees the code enforcement position, about other complaints. Brown said he hasn't received many complaints. One concerning a dog was a simple mistake, Brown noted.

"I feel she is doing a job that wasn't getting done before," mayor Orville Tonsing said. Council members agreed a lot of areas have been cleaned up because of the code enforcement position.

Council member Steve Moore said the police committee has talked about transitioning the position back under the jurisdiction of the police department but feels now is not the right time as they are understaffed.
